

Terms of Use Website

Please read these terms and conditions carefully before using this site.

1. What is in these terms?

These terms tell you the rules for using our website www.dattel.asia (“our site”).

2. Who we are and how to contact us

3. By using our site you accept these terms

By using our site, you accept these terms of use and that you agree to comply with them. If you do not agree to these terms, you must not use our site.

These terms of use refer to our Privacy Notice, which sets out the terms on which we process any personal data we collect from you, or that you provide to us. By using our site, you consent to such processing and you warrant that all data provided by you is accurate.

4. Cookies
